- *Note: Deposits are non-refundable unless the puppy becomes unavailable due to a health issue or other unforeseen circumstances as determined by the seller. The puppy will not be placed on hold until the deposit is received. Payments can be accepted via Good Dog, Zelle, Square, Venmo, or cash.*

- *The remaining balance must be paid in full 48 hours before the puppy is released from the seller's care. This balance does not include any fees for transportation.*
- *The buyer must arrange the transportation method and transportation fees prior to picking up the puppy.*

What's Included with Your Puppy

Each puppy will go to their new homes with a personalized Go-Home Package. This package will come with a blanket that carries the litter's scent, a collar, chew toy, a sample bag of the puppy's current food, training pads, veterinary records (vaccine and health records), etc.



Full Registration

_____ The puppy is sold with full AKC registration and breeding rights. The buyer agrees to breed responsibly and only breed the puppy to **AKC registered, health tested miniature dachshunds**. All litters must be ethically raised and properly registered. This puppy can only be bred if breeding rights were purchased. The puppy's AKC registered name must begin with DKDD.

Limited Registration

_____ The puppy is sold as a **pet only**, not for breeding purposes. Any breeding will void all guarantees and incur a **\$5,000 penalty per litter**. Offspring produced from unauthorized breeding will not be eligible for AKC registration.

Typical Adjustment Period

_____ Going to a new home, meeting new people, meeting new animals, and sleeping alone are big and scary experiences for puppies. Every puppy will react differently to these new experiences. Common signs of stress, especially during the first few days, are crying, barking, upset stomachs, and shivering. All of these behaviors are temporary and typically stop within a week. Please do not get a puppy if you don't believe that you will be able to bear these behaviors.

Health Guarantee

1. _____ The puppy is guaranteed to be in good health at the time of the sale to the best of the seller's knowledge. The buyer has 72 hours from the time of ownership transfer to have the puppy examined by a licensed veterinarian. If this is not completed, this contract is void. If the veterinarian determines that the puppy has a life threatening or genetic defect that substantially threatens the puppy's life, the buyer will need to provide a second licensed veterinarian opinion and then if the buyer chooses to, the puppy can be exchanged for another puppy of equal value, if available, or a puppy from another litter as soon as one is available. If the buyer chooses to take this option, the puppy along with a written statement from the veterinarian and all original paperwork and AKC registration papers are required to be returned within 7 days of the pick up date.
2. _____ DK's Dream Doxies does not cover or guarantee against Intervertebral Disc Disease/ IVDD or any other back issues. Dachshunds are prone to back issues and could develop any issues at any given time.
3. _____ DK's Dream Doxies does not cover or guarantee against Color Dilution Alopecia/ CDA or any other skin issues, especially in dilute colors.
4. DK's Dream Doxies does not cover or guarantee against Progressive Retinal Atrophy/ PRA. DK's Dream Doxies makes no guarantee that the puppy will not develop PRA or related eye conditions.
5. _____ DK's Dream Doxies does not cover or guarantee against any common parasites, worms, minor conditions, or bacterial, viral, or fungal infections . This includes but is not limited to diarrhea, coccidia, giardia, hernias, over/under bites, kennel cough, hepatitis,



hypoglycemia. Issues caused by neglect, accidents, or injury after the puppy has left the breeder's care are also not covered in this health guarantee. All of the veterinarian bills and future liabilities will be the buyer's responsibility once the puppy gets released from the seller's care.

6. _____ Once the puppy has left the seller's care, the seller has no control over the environment that the puppy is exposed to. The seller does not guarantee against parvo or any other diseases. DK's Dream Doxies does not recommend bringing your puppy out unless absolutely necessary until the puppy has received all of its vaccinations.
7. _____ DK's Dream Doxies does not guarantee the size of the puppy once full grown. Miniature dachshunds were bred down from standard dachshunds, so breeders can never guarantee what size the grown dog will be.
8. _____ This puppy has been examined by the seller's vet and all common issues have been addressed and preventatives have been taken. If the buyer's licensed veterinarian finds the puppy to be free of any life-threatening disease or genetic disorders at the time of the first exam, the seller will guarantee the puppy for 6 months for genetic disorders only. Seller reserves the right to consult with buyers veterinarians along with a secondary local veterinarian before deciding course of action.
9. _____ The buyer agrees to not crossbreed, inbreed, or breed without proper DNA and health testing, including PRA, OFA, and patella evaluations. This puppy can only be bred if breeding rights were purchased. The puppy's AKC registered name must begin with DKDD.

Buyer Agreements

1. The buyer agrees to provide the puppy with proper veterinary care, vaccinations, deworming, housing, food, exercise, and socialization.
2. The puppy must never be surrendered to a shelter, rescue, or sold without the breeder's knowledge. If rehoming is necessary, the buyer must notify the breeder first and allow the breeder the option to take the dog back or assist in rehoming. No refunds will be given after the initial 72-hour health guarantee policy.
3. The buyer agrees to never use the dog for fighting or inhumane practices.
4. The buyer agrees that this puppy is being purchased as a pet only with limited AKC Rights. No breeding of the puppy is allowed unless breeding rights were purchased.
5. The buyer agrees to spay/neuter the puppy prior to 18 months of age, as recommended by our veterinarian.
6. This contract is non transferable and is between the seller and the original buyer only.
7. The AKC registered name must begin with DKDD.
8. The buyer agrees to give the puppy the proper time to adjust to being in a new home with a new family.



Entire Warranty

This agreement accounts for the entire agreement between both the seller and the buyer and no other agreements have been made unless included in this agreement or written and signed by both parties. This agreement shall be governed by the laws of the State of Texas.
